## **Opposition to the Barrytown Flats Mineral Sand Mine**

Dear Council Members,

I am writing to express my strong opposition to the proposed mining operation by TiGa Minerals in the Barrytown Flats area on the South Island's West Coast. I believe this venture will have severe and irreversible consequences for the environment and the unique taonga species, the tāiko or Westland petrel. Here are eight compelling reasons why this mining proposal should be rejected:

- 1. **Environmental Destruction:** TiGa Minerals' open-cast mining operation threatens to cause significant and irreversible damage to the coastal ecosystem. This area is of ecological importance, and mining it would disrupt the delicate balance that sustains various species and their habitats.
- 2. **Threat to Taonga Species:** The tāiko, or Westland petrel, is a taonga species and is already vulnerable. The mining method proposed by TiGa Minerals puts this species at great risk. We cannot afford to jeopardize the existence of such a unique and precious bird.
- Uncertain Environmental Impact: Despite assurances from the mining company, there is no certainty regarding how the mining activities will affect local waterways, springs, and the nearby coastal lagoon. Any harm to these water sources could have long-lasting and detrimental consequences for the entire ecosystem.
- 4. Inadequate Oversight: The current local councils have shown a concerning level of leniency and potential conflicts of interest in approving mining projects in the region. The proposed mining project should not be entrusted to councils that might not act impartially.
- Risk to Tourism: The West Coast is celebrated for its scenic beauty and tourism industry. The constant heavy truck traffic resulting from the mining operation will deter tourists and cyclists from enjoying the coastal road, ultimately impacting the local economy.

- Safety Hazards: The already narrow and winding Coast Road poses a significant risk to both cyclists and drivers. Introducing an additional 50 truck and trailer movements a day, as well as 160 car trips, will significantly increase the risk of accidents and fatalities.
- 7. **Alternative Economic Avenues:** The West Coast's economy has diversified over the years, with tourism emerging as a significant contributor. The claim that the region needs every mining project is outdated and ignores the positive economic impacts of the booming tourism sector.
- 8. **Coastal Inundation:** The mining operation could exacerbate coastal erosion and inundation problems that are already plaguing the region. The proposed bund may not be sufficient to protect against the changes in hydrology and rising sea levels, putting local properties at risk.

In conclusion, I strongly urge you to reject the TiGa Minerals mining proposal for the Barrytown Flats. The potential economic benefits do not outweigh the significant environmental damage and risks posed to the region's unique wildlife and tourist industry. I hope the decision-making process is taken out of council hands to ensure transparency and impartiality.
